As the season changes we all need to look at how we do business. On July 1, the Nebraska Real Estate Commission issued some new regulations pertaining to advertising. This includes signage, flyers, business cards, email signature lines, etc. The rules state that the broker's name is to be prominently displayed in a way that is conspicuous, discernible, and easily identifiable by the public. There are many violations to this policy that I see daily. Please look at all your advertising and make sure it is in-line with the rules. You can always ask the Nebraska Real Estate Commission for advice. Remember, the Nebraska Real Estate Commission was set up to protect the public and the public needs to be informed with whom they are dealing with full disclosure.

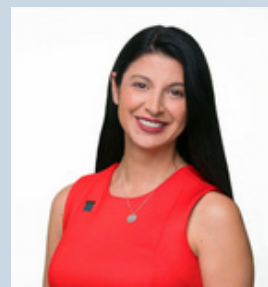

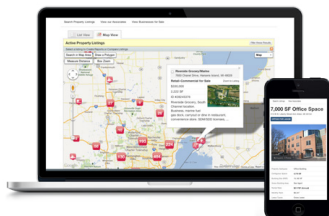

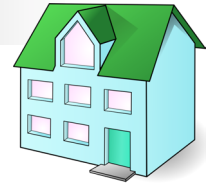

What is a home warranty?

A home warranty is a service contract that helps protect homeowners against the high cost of repairing and/or replacing unforeseen breakdowns of the major appliances and mechanical systems due to normal use.

What is the value of a home warranty?

The value of a home warranty is the fixed service call charge for the repair or replacement potential. Examples of covered items include furnace, air conditioner, water heater, electrical, plumbing, stove, refrigerator, washer, dryer, garbage disposal, trash compactor, sump pump, garage door opener, freezer, etc.

Why do sellers need a home warranty?

Sellers benefit by having valuable protection against the high cost of mechanical breakdowns before, during and after the sale of their home. Studies have shown a home warranty gives confidence to the potential buyers and homes with warranties should sell for more money and faster. FREE LISTING options are available through select warranty companies.

Why do buyers need a home warranty?

Buyers benefit with the peace of mind knowing if there is a mechanical failure, they are protected. Buyers tend to under-estimate the cost of repairs. Most new home owners are not prepared for mechanical /system failures following the closing of the home. FREE EVALUATION options are available through select companies, giving the agent and homeowner an overview of the mechanical systems and major appliances. This can help to "ready" a home for a potential buyer, knowing these items are in working order or if it's not, these can be repaired.

As an agent, what's in it for me?

A home warranty can cushion agents from being involved in home repairs. Homeowners should be calling the home warranty companies instead of agents when there are mechanical failures. A home warranty is also a valuable tool for agents to use during negotiations. Homes could sell for more money and faster. In the competitive real estate marketplace, educating your customers about home warranties and options gives you the overall satisfaction advantage and increases referral potential.

The appliances are old. Are they covered?

Typically, if an appliance is working on the day coverage begins, it is covered. Some companies have prorated coverage for older appliances or a "waiting period" before coverage begins. Please check the terms and conditions on the warranty products.

The appliances are new. Why would I need a home warranty?

Even newer appliances have issues. Generally, a manufacturer has a warranty for the first year, but, failures happen. With a home warranty, there is a backup after the manufacturer's warranty which usually includes parts and labor to fix the appliance or system, with the possibility of a replacement depending on the coverage. Check with your home warranty company for the possibility of a warranty for new construction homes.

They have homeowners insurance. Why do they need a home warranty?

Homeowners' insurance generally covers losses due to fire, theft, vandalism, weather-related conditions, etc. A home warranty protects the homeowner from mechanical failures due to unforeseen mechanical failures and these are not always covered by homeowners' insurance. These are two products that protect the homeowner differently.

What is the cost?

The annual basic cost generally starts at \$450. Additional charges can be added for optional coverage such as additional furnaces, ac's, pools, etc. A home warranty can be paid at closing by the seller, buyer, split between seller and buyer or possibly paid the agents. There is a fee for the service call. This ranges from \$50-\$150.

How do I sign up?

Home warranty companies usually have a local phone number or toll-free number to call in an order or fax in the information. Today, most companies have a website to activate a home warranty on-line, too.

National Flood Insurance Program Extended



On Thursday, September 7, the Senate voted to pass a three-month extension of the National Flood Insurance Program (NFIP). The House of Representatives passed the legislation on Friday, September 8, 2017, and the President signed the bill into law later that day.

This legislation ensures that the NFIP will not lapse on September 30, 2017, and will be extended until December 8, 2017.

The NAR Call for Action concluded Friday, September 8, 2017 at 5:00 p.m. Eastern time. NAR will continue their legislative advocacy efforts for the 21st Century Flood Reform Act until this long-term reauthorization and reform bill is enacted.

According to NAR President William E. Brown, "Extending the National Flood Insurance Program was a must-do item, and Congress delivered. That's good news for consumers, as well as an opportunity for proponents of meaningful reform. With a short extension on their side, leaders in the House and Senate should continue work on the 21st Century Flood Reform Act to strengthen the NFIP and ensure the long-term certainty that current and future homeowners demand."

Code of Ethics: Articles 12 - 15

REALTORS® shall be honest and truthful in their real estate communications and shall present a true picture in their advertising, marketing, and other representations. REALTORS® shall ensure that their status as real estate professionals is readily apparent in their advertising, marketing, and other representations, and that the recipients of all real estate communications are, or have been, notified that those communications are from a real estate professional. (Amended 1/08)

- **Standard of Practice 12-1**

REALTORS® may use the term “free” and similar terms in their advertising and in other representations provided that all terms governing availability of the offered product or service are clearly disclosed at the same time. (Amended 1/97)

- **Standard of Practice 12-2**

REALTORS® may represent their services as “free” or without cost even if they expect to receive compensation from a source other than their client provided that the potential for the REALTOR® to obtain a benefit from a third party is clearly disclosed at the same time. (Amended 1/97)

- **Standard of Practice 12-3**

The offering of premiums, prizes, merchandise discounts or other inducements to list, sell, purchase, or lease is not, in itself, unethical even if receipt of the benefit is contingent on listing, selling, purchasing, or leasing through the REALTOR® making the offer. However, REALTORS® must exercise care and candor in any such advertising or other public or private representations so that any party interested in receiving or otherwise benefiting from the REALTOR®’s offer will have clear, thorough, advance understanding of all the terms and conditions of the offer. The offering of any inducements to do business is subject to the limitations and restrictions of state law and the ethical obligations established by any applicable Standard of Practice. (Amended 1/95)

- **Standard of Practice 12-4**

REALTORS® shall not offer for sale/lease or advertise property without authority. When acting as listing brokers or as subagents, REALTORS® shall not quote a price different from that agreed upon with the seller/landlord. (Amended 1/93)

- **Standard of Practice 12-5**

REALTORS® shall not advertise nor permit any person employed by or affiliated with them to advertise real estate services or listed property in any medium (e.g., electronically, print, radio, television, etc.) without

disclosing the name of that REALTORS®’s firm in a reasonable and readily apparent manner either in the advertisement or in electronic advertising via a link to a display with all required disclosures. (Adopted 11/86, Amended 1/16)

- **Standard of Practice 12-6**

REALTORS®, when advertising unlisted real property for sale/lease in which they have an ownership interest, shall disclose their status as both owners/landlords and as REALTORS® or real estate licensees. (Amended 1/93)

- **Standard of Practice 12-7**

Only REALTORS® who participated in the transaction as the listing broker or cooperating broker (selling broker) may claim to have “sold” the property. Prior to closing, a cooperating broker may post a “sold” sign only with the consent of the listing broker. (Amended 1/96)

- **Standard of Practice 12-8**

The obligation to present a true picture in representations to the public includes information presented, provided, or displayed on REALTORS®’ websites. REALTORS® shall use reasonable efforts to ensure that information on their websites is current. When it becomes apparent that information on a REALTOR®’s website is no longer current or accurate, REALTORS® shall promptly take corrective action. (Adopted 1/07)

- **Standard of Practice 12-9**

REALTOR® firm websites shall disclose the firm’s name and state(s) of licensure in a reasonable and readily apparent manner. Websites of REALTORS® and non-member licensees affiliated with a REALTOR® firm shall disclose the firm’s name and that REALTOR®’s or non-member licensee’s state(s) of licensure in a reasonable and readily apparent manner. (Adopted 1/07)

- **Standard of Practice 12-10**

REALTORS®’ obligation to present a true picture in their advertising and representations to the public includes Internet content posted, and the URLs and domain names they use, and prohibits REALTORS® from: engaging in deceptive or unauthorized framing of real estate brokerage websites; manipulating (e.g., presenting content developed by others) listing and other content in any way that produces a deceptive or misleading result; deceptively using metatags, keywords or other devices/methods to direct, drive, or divert Internet traffic; or presenting content developed by others without either attribution or without permission, or to otherwise mislead consumers. (Adopted 1/07, Amended 1/13)

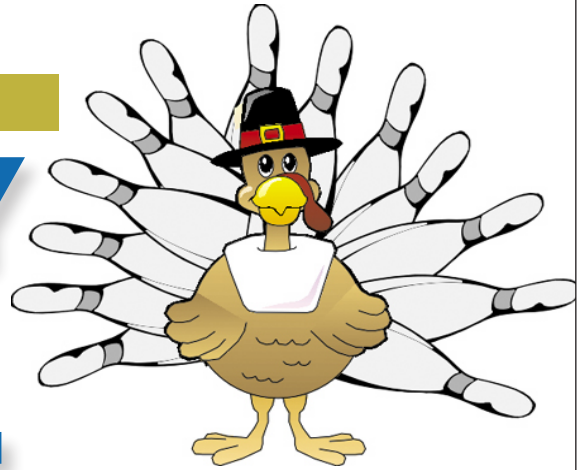
